1. Article I is hereby amended to read as follows:


The name of this corporation is: WRTN Limited, Inc.

The number of votes cast for the amendment by each voting group was sufficient for approval by that voting group.



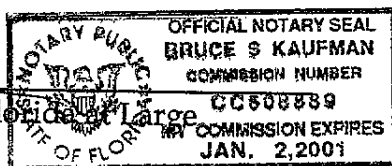
