Attached please find our check #1323 for \$300.00 to pay for the years 2000 and 2001.

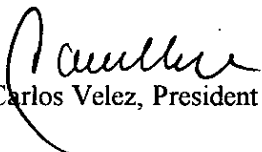
We are requesting that you please waive the penalty for not filing for the year 2000 due to the following:
