We are writing to ask for a clarification and possible waiver on the fee now due on the Dissolution of the above Company.

Here are the events that we wish you to consider:

- 1.) We mailed our check for \$200.00 dated April 30, 1996, along with our Corporate Annual Report. We did not have the new form, so we used a blank photocopy from the prior year with all dates changed following a discussion with your office. The Company's name at the time was Catalina Office Products, Inc.
- 2.) We heard nothing further and thought the matter was taken care of.
- 3.) In August we got the Corporate name changed to Achiever Shredders and Office Products Company, Inc. No one brought up any problem with Corporate Annual Report.
- 3.) We recently received the Notice of Dissolution and Application for re-instatement. We investigated and found the check with the return never cleared.
- 5.) After numerous attempts to get through on your 904-487-6054 (always very busy), a nice young lady listened to our story and advised that the return and check had been sent back to our resident agent in July for a better address. (The address of the Company has never changed, but it is inactive so

Unfortunately our resident agent lawyer had moved to another location on Biscayne Blvd. (This was in the return), about 15 months ago and never got the return to sent to us. We knew nothing until this dissolution notice came in and we investigated the circumstances.

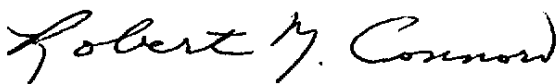
