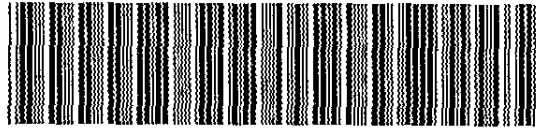



ARTICLE I


