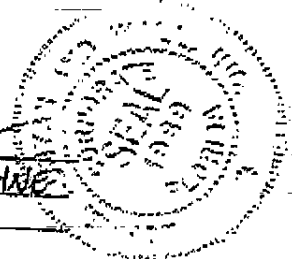
5. All debts, obligations and liabilities of the corporation have been paid or discharged or adequate provision has been made therefor.
