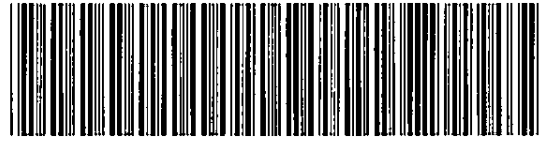

We, the undersigned natural persons of the age of twenty-one or more, acting as Directors and Incorporators under the provisions of Florida Statutes, Chapter 607, adopt the following Articles of Incorporation:

ARTICLE I

Name

This name of this corporation shall be:

ARTICLE II

Principal Place of Business

Purpose

To conduct and carry on the business of buying, selling and dealing in all kinds of seafood or other food products, whether at wholesale, retail or otherwise or through jobbers, distributors, consumers or users, and to engage in such other business or businesses, whether related thereto or not, as may

be approved by the Board of Directors and which businesses are permitted by the laws of the State of Florida.

ARTICLE V

Stock Clause

The aggregate number of shares of stock which this corporation shall have the authority to issue shall be nine hundred (900) shares of common stock, each with a par value of \$1.00.
