No holder of shares of common stock shall be entitled as such as a matter of right to subscribe for or purchase any part of any new or additional issue of stock, or securities convertible into stock, of any class whatsoever, whether now or hereafter authorized, and whether issued for cash, property, services, by way of dividends or otherwise.

The number of votes cast for this amendment by the shareholders is sufficient for approval of the amendment by all voting groups of the Corporation.

4. Upon the filing of these Articles of Amendment with the Department of State, this amendment shall become effective, and the Articles of Incorporation of THOMPSON ELECTRIC OF NORTH FLORIDA, INC., shall be deemed to be amended accordingly.
