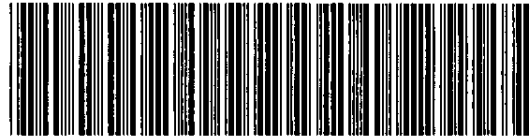

FROM: JOHNSON, AUVIL, BROCK & PRATICO, P.A.


TO: JOHNSON, AUVIL & PRATICO, P.A.


THIRD: The Amendment was adopted by the Board of Directors on the 31st day of August, 2012.
