

- 1. The name\_of\_the Corporation\_is\_JFK,\_Inc.
- The Corporation's existence shall commence January 22, 1990.
- The duration of the Corporation is perpetual.
- The nature of the business or purpose to be conducted by the Corporation shall be to act as a general partner in a limited partnership which is in the business of designing, manufacturing, distributing, selling and installing windows and related products and to do all lawful\_acts\_related\_to\_such business or purpose.
