I remembered completing the form but could not remember mailing it and had no record of check, though I may have forgotten to record it. I was told by a lady that they had not processed all returns and to wait a couple of weeks and call again. I was willing to send another form and check then to avoid additional fee. In checking she found all previous years had been paid before due and said it should be alright.

But I forgot to call and forgot to check future bank statements.

This corporation is a small one and I have been trying to pay creditors and eliminate the deficit of over \$32,000. I have met all previous requirements for maintaining this company and to save expense have not taken compensation.

I am so upset that I did not file and pay this on time this year. I will so much appreciate your help to resolve this and get matters correct again. I do want to keep the company going to pay the debts and so I can still feel useful and not a failure.
