Pursuant to the provisions of Section 607.1101 of the Florida Business Corporation Act, the undersigned corporations adopt the following Articles of Merger for the purpose of merging PARKER MERGECO, INC., into AMERIPLUS, INC., which will be the surviving corporation.

1. A Plan and Agreement of Merger ("Plan") was approved by the shareholders and directors of each of the undersigned corporations in the manner prescribed by the Florida General Corporation Act on the dates set forth below:

PARKER MERGECO, INC.	August 9, 2002
AMERIPLUS, INC.	August 9, 2002

2. The Plan of Merger, provides for the exchange, classification or cancellation of the issued shares as follows:

The method of carrying into effect the Merger provided in the Plan and Agreement of Merger and the manner and basis of converting the shares of the Constituent Corporations into shares of AMERIPLUS, INC. will be the following. At the effective time of the Merger, all of the outstanding Class A Non-Voting common stock (2,220 shares) and all of the outstanding Class B Voting common stock (500 shares) of PARKER MERGECO, INC. shall be converted into 12,650 shares of \$100.00 par, 5% Non-Cumulative preferred stock of AMERIPLUS, INC. upon the surrender to AMERIPLUS, INC. of all of the stock certificates for the stock of PARKER MERGECO, INC. for cancellation.

3. The merger of the undersigned corporation will become effective on the date on which the Articles of Merger are certified by the Florida Department of State.

4. No changes in the Articles of Incorporation of the surviving corporation are required.






