1. The name of the corporation prior to this Amendment is Carl Richfield Lawn Spray, Inc.
2. This Amendment changes the name of this corporation to The Eliminator of Stuart, Inc., and, therefore, old Article I of the corporation's Articles of Incorporation is hereby deleted and new Article I is added and will read as follows.

"ARTICLE I - NAME

The name of the corporation shall be The Eliminator of Stuart, Inc.."
