**THIRD AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SENCOMMUNICATIONS, INC.**


Article III of the Articles of Incorporation of **SENCOMMUNICATIONS, INC.**, were filed with the Secretary of State on January 31, 1990 under document number L46675, as amended, and are hereby amended to delete the present Article III and replace it with the following Article III, as follows:

ARTICLE III


CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock of Five and No/100 Dollars per share par value. Fifty-one percent (51%) of the authorized stock shall be Voting Common, and Forty-nine percent (49%) of the authorized stock shall be Non-Voting Common. Both Voting and Non-Voting Common Stock shall be entitled to identical rights as to distribution and liquidation proceeds. Each Certificate of stock shall reflect whether it represents Voting or Non-Voting Common stock.

The foregoing Second Amendment to the Articles of Incorporation are hereby adopted by all the Shareholders and the members of the Board of Directors of **SENCOMMUNICATIONS, INC.**, effective this 15 day of February, 2001.

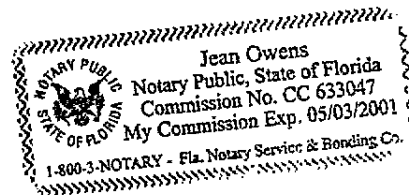

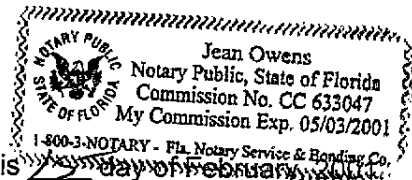

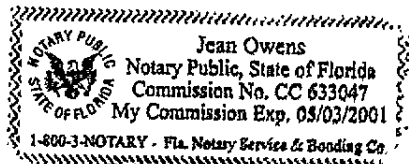
