Dear Ms. Mortham:

I received the 1998 Profit Corporation Annual Report packet on Tuesday, June 30, 1998. This packet is stamped "2nd Notice" and requests a \$400 late fee. Apparently, the report was due June 5, 1998. However, I did not receive a first notice this year. Your office says that it was mailed out, but I did not receive it.

The post office at which I receive my corporate mail has been undergoing remodeling. The post office boxes were torn out and replaced. Perhaps some mail has been lost in the upheaval. In any event, lost or misdirected mail has been a problem at that post office over the years. I often receive mail in my box that was clearly addressed to a different PO box. For example, an annual report packet addressed to Sheridan Lumber at a PO box number that is 74 digits away from mine (not even close!) has been delivered to my box. This has been a common occurrence over the years. Though I am returning the mail that was misdirected to me, perhaps some people simply discard it. Your first notice is not the only piece of mail that I was told had been sent to me but I never received. And I have had similar problems over the years with mail delivered to the various street addresses where I have lived.

I am in the habit of faithfully filing my annual corporate renewal soon after the packet is received each year. Last year, for example, I filed in January. Had I received the first notice, I would have submitted the report and fee on time. I am a freelance writer/editor. This business nets me only about \$11,000 a year and the \$400 late fee is an economic hardship. This burdensome fee penalizes small women-owned businesses such as mine for the failure of the U.S. Postal Service to do its job. I am submitting the original filing fee with this packet and requesting that you waive the \$400 late fee. Please contact me at (305) 696-9894 or (305) 691-7789 so that this matter can be resolved before the next deadline of Sept. 30, 1998.
