**ARTICLES OF DISSOLUTION  
OF  
IDAPAT CORPORATION  
a Florida for profit corporation**

Pursuant to the provisions of §607.1403, Florida Statutes, Idapat Corporation, a for profit corporation organized and existing under the laws of the State of Florida, under document number L48159 filed in the office of the Secretary of State on February 7, 1990 (under the name "Global Success Corporation") (the "Corporation"), adopts the following articles of dissolution for the purpose of dissolving the Corporation:

**ARTICLE I**

The name of the Corporation is Idapat Corporation.

**ARTICLE II**

The effective date of the dissolution is the later of (i) the date upon which these Articles of Dissolution are filed with the Florida Secretary of State or (ii) 11:59 p.m. on September 30, 2002.

**ARTICLE III**

The dissolution was authorized by resolution of the board of directors on May 10, 2002, and by approval of the shareholders on May 10, 2002.

**ARTICLE IV**

No voting by classes of shareholders is required and the vote of shareholders was sufficient for approval of dissolution.
