Pat's Homemade Bar-B-Q Sauce, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, do hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed with the secretary of the State of Florida on February 8, 1990, under the name of Pat's Homemade Bar-B-Q Sauce, Inc.
2. The Amendment to the existing Articles of Incorporation be and effect hereby is that resulting from completely deleting Article I of the Articles of Incorporation as of the date hereof, and substituting in its place the Article set forth below.
3. As amended below Article I of the Articles of Incorporation has the sole effect of changing the Corporation's name from Pat's Homemade Bar-B-Q Sauce, Inc. to "Pat's Ho-Made Bar-B-Q Sauce, Inc".
4. This amendment to the Articles of Incorporation was approved by unanimous joint written action of the stock holders and board of directors of the Corporation, adopted on the 20<sup>th</sup> day of December 1996.
5. These Articles of Amendment of the Articles of Incorporation shall be effective immediately upon filing by the Secretary of State of the State of Florida, all required taxes and fees having been paid, hereafter, the name of the Corporation shall be "Pat's Ho-Made Bar-B-Q Sauce, Inc." and Article I of the Articles of Incorporation of the Corporation shall read as follows:

**ARTICLE I  
PAT'S HO-MADE BAR-B-Q SAUCE, INC.**
