

## ARTICLES OF AMENDMENT OF SIX SIGMA QUALTEC, INC.

Pursuant to the provisions of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned corporation adopts these Articles of Amendment.

FIRST: The name of the Corporation is Six Sigma Qualtec, Inc.
