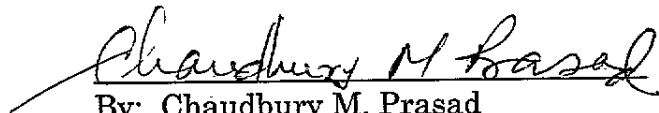
1. The name of the corporation filing these Articles of Dissolution is Spargos Advertising, Inc. (the "Corporation").
