As we discussed on the phone today: In April 2000, I sent in the Annual Report and the \$158.75 fee for Consulef Corporation. I sent it in the same envelope as the Annual Report and fee for The Heraldry Corporation. The reports were sent certified mail to the PO Box 1500. The receipt card (copy enclosed) indicated that the reports were received on May 5, 2000.

Although I did receive the Certificate of Status for The Heraldry Corporation dated June 6, 2000, I never received the Certificate of Status for Consulef Corporation. Also, the check for Consulef Corporation, in the amount of \$158.75, was never presented to my bank for payment.

After Christmas 2000, I received a Notice of Administrative Dissolution for Consulef Corporation. It had been forwarded from a Florida address to our current address in New York State. Obviously mail between Florida and New York was more than slow.

I do not believe that my company should be penalized for what appears to be a clerical error in processing the paperwork for Consulef Corporation. As we discussed, I would like to have Consulef Corporation on an active Status in the State of Florida. Therefore I am doing as you requested and sending in the paperwork, with the \$150.00 fee for the Annual Report and the additional fee of \$8.75 for the Certificate of Status.
