Dear Mr. Toner;

In talking to your representative today, I have come to realize that we were under the mis conception that we had paid our 2005 corporate fee at the proper time. The enclosed subject letter was a response to a report submittal for 2005 which we thought was paid previously, (November 1, 2004) a copy of the bank statement enclosed. I came to realize that it was for 2004 not the 2005 year.

The enclosed report was a response to me not being able to find payment proof claimed by my wife, so I got a report via e-Mail and submitted to report and corresponding check, also enclosed.

I do not believe that we received notices after January 15, 2005 because we changed our address to the one above. We did this because wee sold the assets, The Dry Cleaner, to The Great White Cleaning Company, Inc. on that date. The enclosed report that I pulled on a date some months prior to the date of the check clearly shows an incorrect address, which I changed when I sent the report and check to your department.

Other factors that are reasons we did not pay the fee until October of this year other then incorrectly believing that we had already paid the fee, Are as follows.

The notices were not received or forwarded by the new owner of the assets and the address that the reports were going to.

We were out of town from March to May 2005 for medical reason involving my Wife.

We were busy conducting repairs and seeking contractors for our house because of hurricanes of

September 2004. This work was finished only one week prior to the hurricane Wilma in October 2005.

The hurricane Wilma of 2005 again caused considerable damage to our home in fact more than that sustained in 2004.

Immediately after the hurricane Wilma in October 2005, My wile's medical condition was addressed and unfortunately other medical concerns were discovered which necessitate two more hospital stays totaling 13 days on the first one and one week and a half later an 11 day hospitalization. This does not take into consideration Doctor visits, diagnostic test, outpatient procedures and a total of several weeks of constant care on my part. Suffice it to say that since the Monday after Hurricane Wilma the time is one big medical blur.

The non payment of the fee of 2005 we believed we paid in November of 2004. The check sent for 2005 in October was in response to a notice reminder in the documents uncovered in the house and a response to activate a remedial action until the payment proof was found. We were wrong in our assumption that we had already paid the 2005 fee.

However it was not intentional and we request a reinstatement for this and to other reasons stated above.. The original check of October is enclosed and an additional one for 2006 is also enclosed, as requested by your associate that I talked to today.
