ARTICLES OF AMENDMENT TO THE SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION OF BIODERM, INC.

Pursuant to the Florida Business Corporation Act, **BIODERM**, **INC.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation, as amended:

FIRST: The name of the Corporation is:

BioDerm, Inc.

SECOND: Article IV.A. of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended and restated in its entirety as follows:

Authorization of Stock. This corporation is authorized to issue two classes of stock to be designated, respectively, common stock and preferred stock. The total number of shares that this corporation is authorized to issue is One Hundred Million (100,000,000). The total number of shares of common stock authorized to be issued is Seventy Million (70,000,000), par value \$0.0001 per share (the "Common Stock").
