4. Article II of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

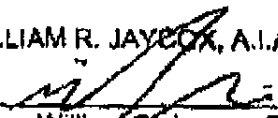
ARTICLE II: BUSINESS, OBJECTS, OR PURPOSES
