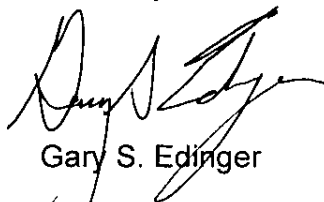

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
BENJAMIN & AARONSON, P.A.**

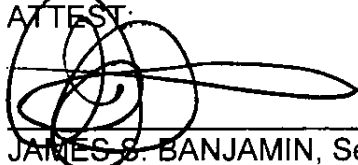
