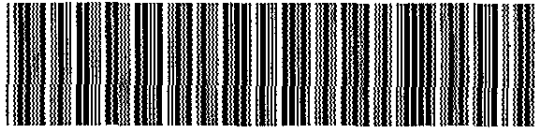

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Second Articles of Amendment to its Articles of Incorporation.

1. The name of the corporation is Security One Systems, Inc.
2. Pursuant to Article IV - Capital Stock of the Articles of Incorporation, the corporation is presently authorized to issue 500 shares of \$1.00 par value common stock which is designated as common shares.
