




Notice is hereby given, pursuant to the provisions of Section 607.1407 of the Florida Business Organizations Code, that Gulf Coast Hot Mix Equipment Leasing, Inc. has been dissolved by resolution of its director and shareholder. Articles of Dissolution have been filed with the Florida Secretary of State on April 3, 2009, as required by law, and were effective March 31, 2009.
