Lynn Carlson (requested name) by which name Petitioner shall hereafter be known.

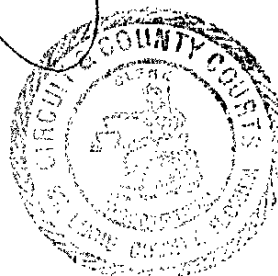
