FIRST: Pursuant to Section 607.1003 of the Florida Statutes, the Articles of Incorporation of Afcom, Inc. are hereby amended to delete the provisions of Article I as the same now exists, and by substituting in lieu thereof, the following:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be ROGERS & ANDERSON HOLDINGS OF SEMINOLE COUNTY, INC.

SECOND: The foregoing Amendment was adopted by a Written Action of All Shareholders and Directors of Afcom, Inc. on February 5, 1999, which manifests an intent to amend the Articles of Incorporation effective upon the filing of this Amendment with the Secretary of State.

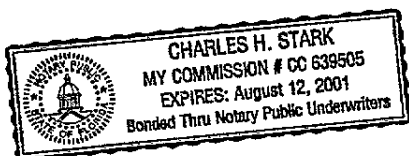
