**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF

Pursuant to the Florida Business Corporation Act, Article I of the Articles of Incorporation of **MOBILE PICTURE FRAMING, INC.**, a Florida corporation (hereinafter referred to as the "Corporation") is amended to read as follows:

ARTICLE I


The name of the Corporation shall be: **Cazabak of Miami, Inc.**
