Dale K. Bohner, P.A., a Florida corporation, executes the following articles of dissolution pursuant to section 607.1403 of the Florida Business Corporation Act:

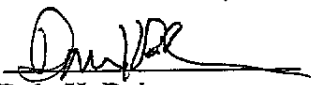
FIRST: The name of the corporation is Dale K. Bohner, P.A. (the "corporation").
