Per my telephone conversation of today's date with a representative of the Reinstatement Section, I am providing written information about the above Corporation's dissolution situation.

I was advised that the reason why the dissolution was executed was because no payment had been received during 2003 for the Corporate Annual Report.

As in the case of International Finishes, Inc., a sister company, the only reason why this fee was not paid this year is because the 2003 filing documents were not received, and the only possible explanation for this is because they were most likely sent to the company's previous address on Park of Commerce Boulevard.

AK Finishes moved its offices effective January 01, 2003, to the new address shown on the Reinstatement document we received and which is shown in the Letterhead above.

The Post Office only forwarded our mail for one month after our move, which is why it is apparent that we never received the 2003 filing documents.
