The undersigned do hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of Grupo Grifols de America, Inc.


1. The name of the corporation is currently GRUPO GRIFOLS DE AMERICA, INC.

4. The effective date of this Amendment shall be upon the filing of this Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.


