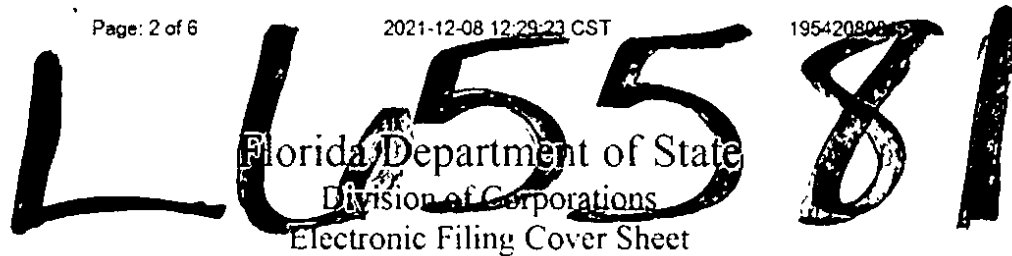

**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
SYMBIONT SERVICE CORPORATION**

Pursuant to Chapter 607 of the Florida Business Corporation Act (the "Act"), SYMBIONT SERVICE CORPORATION (the "Corporation"), a Florida corporation organized and existing under the Act, does hereby certify:

1. The Articles of Incorporation of the Corporation were initially filed with the State of Florida on April 16, 1990.

2. The Corporation hereby adopts these Amended and Restated Articles of Incorporation (the "A&R Articles"), which replace the original Articles of Incorporation, as may have been amended from time to time.

3. The A&R Articles were duly approved and adopted by unanimous written consent of the sole shareholder (the "Shareholder") and sole director (the "Director") of the Corporation, dated December 8, 2021. The number of votes cast by the Shareholder and Director were sufficient for approval.

4. The original Articles of Incorporation are hereby superseded and replaced in their entirety by the A&R Articles, which are as follows:

ARTICLE I - NAME

The name of this Corporation is:

SYMBIONT SERVICE CORPORATION

ARTICLE II - TERM OF EXISTENCE

The Corporation is to exist perpetually.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
