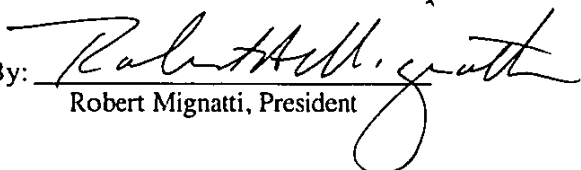
ARTICLE I - NAME
