**ARTICLES OF AMENDMENT
TO THE
THE ARTICLES OF INCORPORATION
OF**

Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, All-Med Services of Florida, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is All-Med Services of Florida, Inc., (hereinafter called the "Corporation").

2. Section 9 of the Corporation's Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"The Corporation shall indemnify any present or former officer or director exercising powers and duties as an officer or a director of the Corporation, to the fullest extent now or hereafter permitted by law."

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.

4. The amendment made herein to the Articles of Incorporation of the Corporation was adopted by the unanimous written consent of the Shareholders and Directors as of May 23, 2011, the number of votes cast for the amendment was sufficient for approval.

5. The effective date of this Amendment shall be upon the filing of these Articles of Amendment.
