OR SELECTION OF THE PARTY OF TH WHEREAS, the Articles of Incorporation of CURT GENDERS, P.A. were filed with and approved by the Secretary of State of the State of Florida on the 19th day of April, 1990, effective April 18, 1990, and

WHEREAS, an Amendment to the Articles of Incorporation of CURT GENDERS, P.A. was filed with and approved by the Secretary of State of the State of Florida on the 29th day of June, 2000; and

WHEREAS, it is the intention of the sole director and the sole stockholder of CURT GENDERS, P.A. that the Articles of Incorporation of CURT GENDERS, P.A. be amended effective January 1, 2001, in accordance with the proposed amendments hereinafter set forth; and
