WHEREAS, the Articles of Incorporation of **CURT GENDERS, P.A.** were filed with and approved by the Secretary of State of the State of Florida on the 19th day of April, 1990, effective April 18, 1990, and

WHEREAS, an Amendment to the Articles of Incorporation of **CURT GENDERS, P.A.** was filed with and approved by the Secretary of State of the State of Florida on the 29th day of June, 2000; and

WHEREAS, it is the intention of the sole director and the sole stockholder of **CURT GENDERS, P.A.** that the Articles of Incorporation of **CURT GENDERS, P.A.** be amended effective January 1, 2001, in accordance with the proposed amendments hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Incorporation of **CURT GENDERS, P.A.** hereinafter set forth was approved and adopted by the sole director and by the sole stockholder, comprising the only voting group of stockholders, of **CURT GENDERS, P.A.**, pursuant to the provisions of Florida Statutes, Section 607.1003(5), on the 29th day of NOVEMBER, 2000; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendments hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of **CURT GENDERS, P.A.** are hereby amended effective January 1, 2001, by deleting in its entirety the present Article I, and by substituting therefor the following, to-wit:

NAME

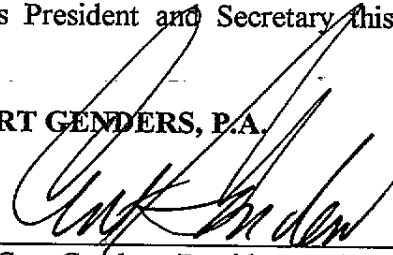

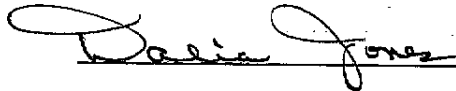
