As per our conversation yesterday, we are requesting the re-instatement fee be abated for "reasonable cause". Mr. Slager is enclosing payment in the amount of \$400.00 for filing fees to re-instate his corporation for <sup>1995</sup>1994 and <sup>1996</sup>1995, as per your instructions.

Mr. Slager had no prior knowledge that his corporation was in risk of being dissolved, due to the negligence of Mr. King, Custom Business Accounting, who was responsible for advising Mr. Slager on mandatory filing requirements. Mr. Slager is not familiar with all the necessary paperwork required by I.R.S., Dept. of Labor, Soc. Security Administration, and your office, and relied on Mr. King to give him proper professional guidance.

Mrs. Snyder, Internal Revenue agent - Sarasota Office (now retired) has information documented that Mr. King was negligent to his clients and was about to close Mr. King's office on March 17, 1996, but Mr. King "passed away" March 11, 1996 before she could present him with formal papers. Mr. King was an enrolled I.R.S. agent, with many years accounting experience. In many cases he had Power of Attorney thus many notices, forms, etc. were sent directly to him, thereby bypassing the person responsible for administering the check for the filing fees. There was no explanation why he failed in his duties. I have undertaken the responsibility of Mr. King's clientele. This is not the first client I have encountered whose corporation unknowingly has been dissolved. We have been told by other clients that Mr. King told them once they were incorporated and paid the initial fee, that was it. They were not required to do or pay anything else from that point on.

Mr. Slager was shocked to discover that his business had been dissolved in 1995. When verifying if Mr. Slager had received his Annual Corporation Report for this year, he stated that he had not and was not aware that he was supposed to receive one. This led us to check with your office which verified that the business had been dissolved. This is a very typical action of Mr. King's from the evidence in this office.


I have taken action to correct the many problems created by Mr. King.

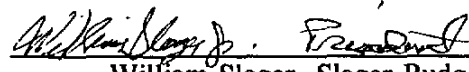
