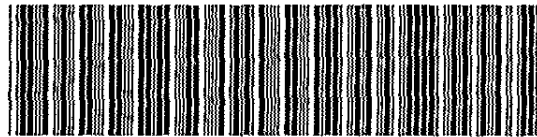




RESIGNATION OF REGISTERED AGENT
