

The corporation shall be deemed dissolved upon filing of these Articles.



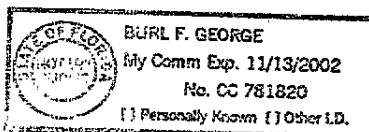
