As I believe in the system working, the enclosed check is for the original amount levied, \$150.00.

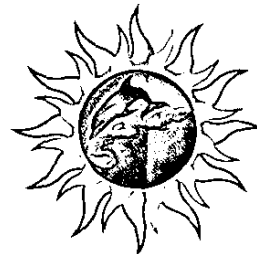
