My father, Michael J. Dougherty, died of a sudden heart attack in February 2006. He ran and managed the operations of MJGW, Inc.


In April, my mother completed your required paperwork and mailed it along with the required \$150.00 fee, check # 1837 drawn on MJGW Inc's Bank of America account.
