FINAL JUDGMENT ON ALIMONY AND EQUITABLE DISTRIBUTION

THIS CAUSE came on to be heard on the duly noticed Court's pronouncement of findings of fact and conclusions of law on alimony and equitable distribution on January 11<sup>th</sup>, 2005 at 2:00 p.m.

For equitable distribution the Court finds and orders as follows;

AmeriCuba, to the Husband. The husband has a 50 percent interest in this business. The value of that as of July 1<sup>st</sup>, 2004 is \$49,400, which the Court gives to the Husband.

Tampa Envios Inc., the Husband is 100 percent owner. The value of the incorporation as of July 1<sup>st</sup>, 2004 is \$3,150 which the Court gives to the Husband.

Metropolis, Inc., the value as of April 30<sup>th</sup>, 2003 is \$143,000, which the Court gives to the Husband.

The Spain Bank Account, effective April 21<sup>st</sup>, 2003. The Court values the account at \$7,113.82 and the Court gives it to the Wife.

The Fawn Ridge property, the note payable \$720.00 a month will be divided equitably between the parties.

The home of the wife, the Court values at \$176,000.00 as of January 16<sup>th</sup>, 2004 and the Court gives it to the Wife.

2919 West Columbus Drive, that is the property that the Tampa Envios building and adjoining property. This property as of March 29<sup>th</sup>, 2004 is worth \$113,000 subject to a mortgage of \$36,503.60. The equity there is \$76,497. The Court values it at \$113,000 pursuant to the appraisal.

The Oppenheimer Account, the Court values at \$97,000 and the IRA the Court values at \$18,587. The Oppenheimer and the IRA are given to the Wife.
