These Articles of Amendment are made to the Articles of Incorporation of MARC D. SHAPIRO, M.D., P.A., a Florida professional service corporation (the "Corporation" for the purpose of changing the name of the Corporation from MARC D. SHAPIRO, M.D., P.A. to EXCELLENCE IN MRI, P.A.

- I. The name of this corporation is Marc D. Shapiro, M.D., P.A.
- II. The Articles of Incorporation of the Corporation are hereby amended as follows:
 - A. Article I - Name is hereby amended to delete "Marc D. Shapiro, M.D., P.A." and substitute therefor "Excellence in MRI, P.A."

III. The Amendment to the Articles of Incorporation of the Corporation as contained in these Articles of Amendment were adopted on the 4th day of June, 2002.

IV. These Articles of Amendment were approved by the shareholders and the number of votes cast for these Articles of Amendment by the shareholders was sufficient for approval. The Corporation has a single class of voting stock.

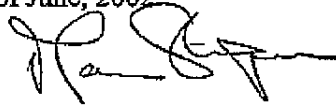

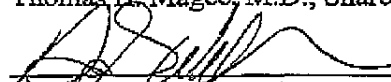
