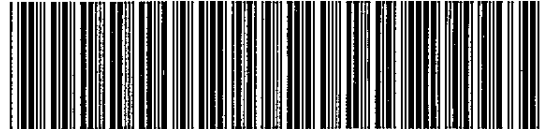




AMENDMENT TO ARTICLES OF INCORPORATION OF

4. The Amendment was adopted by the Board of Directors, who are also the sole shareholders of the corporation.


