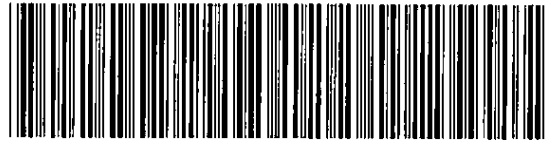

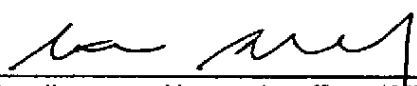

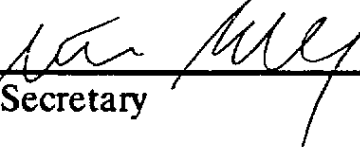
Steven Blasbalg presided over the meeting as chairperson and Margarita Blasbalg acted as secretary, taking the minutes of the meeting.

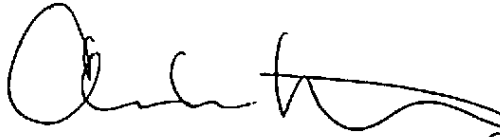

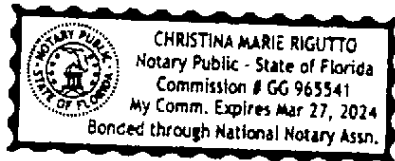
