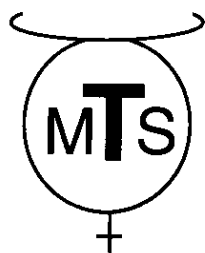

Enclosed please find the updated Uniform Business Report for Mercury Technology Services, Inc. along with our Check #16980 for \$550.00.


Due to an oversight on my part, the report due May 1, 2002 was not sent in. The second original with the September 1 deadline was misplaced in our move of August 1, 2002.
