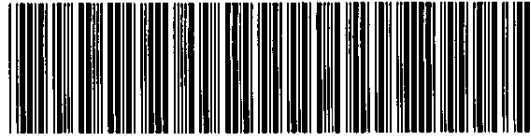

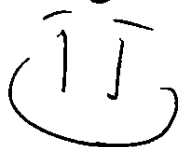

following Articles of Amendment to its Articles of Incorporation:

I

That the name of the corporation is MARINE UNDERWRITERS, INC.

II

That the following amendment to the Articles of Incorporation was adopted by the  
shareholders and the board of directors of the corporation on December 23, 2008 amending Article  
I of the Articles of Incorporation to read as follows:

"ARTICLE I - NAME

The name of this corporation shall be and is hereby declared to be "RON RABY, INC."
