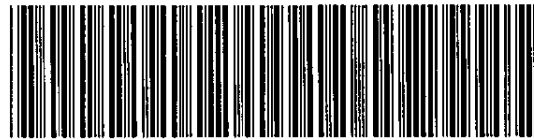

**AMENDED AND RESTATED  
ARTICLES OF INCORPORATION FOR  
THE LAW OFFICE OF GLEN J. TORCIVIA AND ASSOCIATES, P.A.**  
  
**(a Florida Professional Corporation)**

**Article I  
Name of Corporation**

The present name of the professional corporation is THE LAW OFFICE OF GLEN J. TORCIVIA AND ASSOCIATES, P.A. (the "Corporation").

**Article II  
Commencement of Existence**

The Articles of Incorporation for the Corporation were filed on May 18, 1990 and assigned Florida document number L73980. The Corporation commenced existence on that date and shall have perpetual existence unless sooner dissolved according to, as applicable, its Bylaws or law.

**Article III  
Name Change**

The name of the Corporation is hereby amended and the new name shall be TORCIVIA, DONLON, GODDEAU & ANSAY, P.A.

**Article IV  
Principal Office**

**Article V  
Purpose of Corporation**

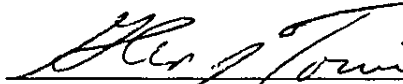
**Article X**

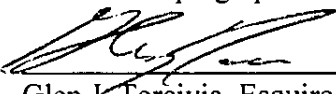
