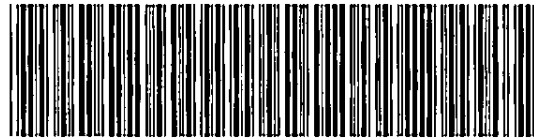

(a Florida Professional Corporation)

**Article I
Name of Corporation**

The present name of the professional corporation is **TORCIVIA, DONLON & GODDEAU, P.A.** (the "Corporation").

**Article II
Commencement of Existence**

The Articles of Incorporation for the Corporation were filed on May 18, 1990 and assigned Florida document number L73980. The Corporation commenced existence on that date and shall have perpetual existence unless sooner dissolved according to, as applicable, its Bylaws or law.

**Article III
Name Change**

The name of the Corporation is hereby amended and the new name shall be **TORCIVIA, DONLON, GODDEAU & RUBIN, P.A.**

**Article IV
Principal Office**

**Article V
Purpose of Corporation**

The specific purpose for which the Corporation is formed is to perform professional services and more specifically to engage in the practice of law, and to render such services subject to the Florida Business Corporation Act, including all amendments thereto, and subject to the restrictions imposed on professional corporations by the Florida Professional Service Corporation and Limited Liability Company Act, including all amendments thereto, and shall be authorized to

Quorum and Voting Requirements

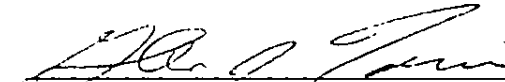

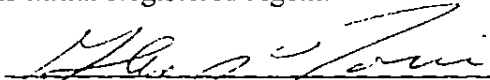

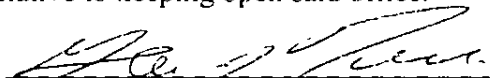
