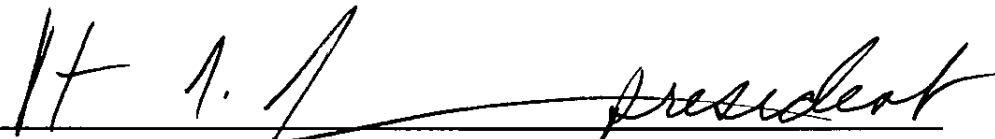
**NOTICE OF DISSOLUTION OF PETER S. SCHWEDOCK,
